INTRODUCTION:

This monthly information report provides an update to the Edmonton Police Commission on the Edmonton Police Service's authorized full time equivalencies versus actual full time equivalencies for the time period of 2013 January 01 to 2013 February 28 inclusive.

COMMENTS/DISCUSSION:

As of 2013 February 28, we were above overall authorized strength by 10.56 sworn member FTE's, despite being under 8 FTE's related to secondments. We were under authorized strength by 36.83 non-sworn members FTE's (including the Edmonton Police Commission) for a total of 26.27 FTE's under authorized strength.

Included in the above sworn numbers are the 50 recruits that have not gone out onto the street.
