INTRODUCTION:

This monthly information report provides an update to the Edmonton Police Commission on the Edmonton Police Service's authorized full time equivalencies versus actual full time equivalencies for the time period of 2015 January 01 to 2015 March 31 inclusive.

COMMENTS/DISCUSSION:

As of 2015 March 31, we were under authorized strength by 4.12 sworn member FTE's. We were under authorized strength by 10.59 non-sworn members FTE's for a total of 14.71 FTE's under authorized strength.

Included in the above sworn numbers are the 83 recruits and pre-hires that have not gone out onto the street.
