INTRODUCTION:

This monthly information report provides an update to the Edmonton Police Commission on the Edmonton Police Service's authorized full time equivalencies versus actual full time equivalencies for the time period of 2015 January 01 to 2015 February 28 inclusive.

COMMENTS/DISCUSSION:

As of 2015 February 28, we were under authorized strength by 10.17 sworn member FTE's. We were under authorized strength by 13.57 non-sworn members FTE's for a total of 23.74 FTE's under authorized strength.

Included in the above sworn numbers are the 77 recruits and pre-hires that have not gone out onto the street.
